5. Open Class entries must be made on an Open Class Entry form or photo copy of form.
6. Entries must be signed by member, parent and club advisor/or teacher if a school project.
7. On **July 18th** all Jr. Fair exhibitors will be mailed verification of their entry. If you do not receive this notice it is your obligation to contact the fair office to confirm entries.

Swine – make an entry for each animal; maximum of 2 entries (single only)

Horse/Pony – only one entry per horse/pony; must list horse/pony name
Poultry/Rabbit – make sure sex and age are correct.
