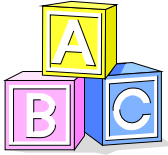
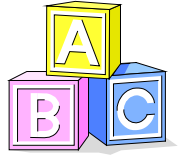


2010 HARTFORD FAIR ANNUAL BABY QUILT CONTEST

RULES: All baby quilts entered must be your own work. Exhibitor must complete entry form and pay entry fee by Saturday July 10th, 5:00 p.m. If entry form and fee are mailed to Secretary's office, entry tags may be picked up at the secretary's office when you arrive at the fair with your entries. These entries will be accepted at the Arts & Crafts Building on **Friday August 6th, 12 noon-9 pm or Saturday August 7th, 9am – 12 noon**. Each exhibitor may enter more than one quilt per lot. Entry tags (to be obtained from the secretary's office.) must be attached to the exhibit. Name must be on the inside of the tag and under no circumstances be unfolded to reveal the exhibitors name until after judging. Please fasten securely to the quilt.
