### DOG SCHEDULE

**Saturday, August 6<sup>th</sup>**

Registration (Grubb Arena, West) 8:00 am  
Dog judging (Grubb Arena, West) 8:30 am

#### General Rules

1. Dogs participating in the Hartford Fair Dog Obedience, Showmanship and You and Your Dog activities must either be owned by the junior fair exhibitor or the exhibitor's immediate family. They must be in the continual care of the junior fair exhibitor for the duration of the project. The date of ownership must be no later than April 1. Proof of ownership is the burden of the exhibitor and the exhibitor's family. Hardship cases will not be considered for the Hartford Fair participation
  - a. Immediate family is defined as the junior fair exhibitor's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including the corresponding step and half relations, or by a member of the exhibitor's household.
  - b. Continual care is defined as the junior fair exhibitor being responsible for and involved in the feeding, cleaning, and caring of the project.
  - c. Hardship cases are defined as dogs that replace the original project enrolled by the exhibitor after the county's enrollment deadline, or no later than April 1.
2. Leasing or two youth sharing a dog is not permitted for Hartford Fair dog show participation.
3. Lessons, instruction and advice for the exhibitor are encouraged. As long as the exhibitor is present in the learning situation, and handles or trains the dog the majority of the time present, such assistance can include occasional handling or training by another person. Only the exhibitor can train the dog at any type of training class on or after April 1.
4. No one other than the Jr. Fair exhibitor is permitted to show the project dog at any type of dog show, including agility, field trails, rally trails, etc., as well as fun matches, on or after April 1st.
5. 4-H members must be enrolled in the correct dog project to show in classes at the Hartford Fair as follows: Obedience, Project No. 2010 to show in Beginning Novice, Pre-Novice, Novice, Graduate Novice, Open, Graduate Open, Rally classes. Showmanship, Project No. 201S to show in Showmanship. Working Dog Project No. 201W to show in the Assistance Dog Class. The interview question for Showmanship will come from the Ohio 4-H Dog Resource Handbook 201R.
6. Only domestic dogs can be shown at the Hartford Fair Junior Fair Dog Show. Wolf and wolf hybrids are not permitted.
7. All dogs exhibited at the Hartford Fair must be six months of age by the date of the show. This includes Pilot Dog puppies and other assistance dogs. Proof of age is the burden of the exhibitor or exhibitor's immediate family. Dogs not meeting this age requirement cannot be shown.
8. Junior Fair exhibitors in respective activities and classes are expected to perform in those events and demonstrate those skills which are listed in the Ohio 4-H Dog Resource Handbook, Ohio 4-H Dog Project and Record Book, and on various dog 4-H judging score sheets.
9. Youth taking Assistance Dogs may show their Assistance Dogs in one Beginning Obedience class (Beginner Novice A, Beginner Novice B, or Pre-Novice) that meets the exhibitor's experience eligibility.
10. **Misbehavior and Exclusively for Dogs on the Fairgrounds, Show Area, or in the Show Ring**
  - a. Any dog exhibiting unsafe or threatening behavior at any time before, during or after exhibition will be removed from the fairgrounds.
  - b. The Judge or show official will dismiss from the ring any dog exhibiting unsafe or threatening behavior
    - i. The judge will excuse any dog that appears dangerous to other dogs or exhibitors.
    - ii. Any dog that snaps, attempts to attack, or attacks any person or dog while in the show ring will be excused.
    - iii. If a judge determines that a bitch in the ring is in season or appears to be so attractive to males as to be a disturbing element, the bitch is excused. The judge shall not obtain the opinion of the health check officials
  - c. Any uncontrolled behavior such as barking, running away from its handler, etc., will be penalized according to the seriousness of the misbehavior, whether it occurs during, or between an exercise or before or after judging.
  - d. Any dog not under its handler's control may be excused from competition
11. The 4-H and FFA professionals and show officials in charge will have the right and responsibility to order the removal from the grounds any person verbally or physically abusive to show personnel.
12. Only the exhibitor's dog, exhibitor, and show officials are permitted on the show arena floor at any time throughout the show
13. All dogs participating in the Hartford Fair must be currently licensed in the exhibitor's county of residence. The exhibitor must bring a certificate of license to health check. The dog license tag alone is not sufficient. This includes Assistance Dogs. The Assistance Dog Organizations (i.e. Pilot Dogs, Inc.), will provide the appropriate document for exhibitors to get a license for their dogs
14. Health Requirements:
  - a. All dogs must be immunized against distemper, hepatitis, leptospirosis, parvo virus, parainfluenza, rabies by a licensed, accredited veterinarian. Bordetella vaccination is recommended, but not required.
  - b. The required vaccinations must be current by day of show and have been given by a licensed accredited veterinarian.
  - c. Veterinarians must note any deviations from the required vaccinations (i.e. leptospirosis vaccination not given by veterinarian or dogs titer tested in lieu of vaccinations) either on the current year Junior Fair Dog Show Certificate of Vaccination or on veterinarian's letter-head that accompanies the official health papers
  - d. A current year Licking County Dog Project Identification Form and Vaccination Certificate signed by a licensed, accredited veterinarian is required. These certificates must include the name, breed and age of dog. Other certificates of vaccination, computerized vaccination records, pet record cards, or kennel records will not be accepted. When getting a current year Licking County Dog Project Identification Form and Vaccination Certificate, be certain the dates of the required vaccinations, including the rabies vaccination, are listed by the veterinarian. Most dogs, unless it is their first time for a rabies vaccination, will receive or have received a three-year vaccine. The veterinarian must circle which vaccination (1 yr. Or 3 yr.) was given and record the date it was given. Health certificates must be completed and signed by the veterinarian.
  - e. Before going to Registration, exhibitors must bring their dog license certificate, and current year Licking County Dog Project Identification Form and Certificate of Vaccination to Health Check. Incomplete or falsified information is grounds for dismissal.
  - f. These are the vaccination requirements for showing a dog at the Hartford Fair. It is the exhibitor's responsibility to make sure that these vaccination requirements for the Hartford Fair are met.
15. Any dogs exhibiting abnormalities or symptoms of sickness, disease, or parasite infestation as determined by the health check officials, will be eliminated from the show and must be removed from the Fairgrounds. If a dog is under veterinary care for a health condition that is not infectious or contagious, the exhibitor must bring a health certificate from the attending veterinarian verifying the condition and treatment. Decision of the show health check officials is final.
16. Dogs must be kept on leash while on the fairgrounds, except when participating in the ring during judging. Exhibitors are totally responsible for their dogs while on the fairgrounds. Exhibitors are expected to clean up after their dogs. Dogs must not be left unattended.
17. Bitches showing signs of heat are not permitted to compete and are not permitted on the Fairgrounds. Each dog must go through a health check where all females will be checked for signs of heat. If a bitch shows any signs of heat, she will be eliminated from the show and must be removed from the Fairgrounds. Any bitch, which appears so attractive to males as to be a disturbing element, will be eliminated from the show and must be removed from the Fairgrounds. Decision of the health check officials is final. Pregnant or lactating (nursing) bitches may not be shown and are not permitted on the fairgrounds.
18. Exhibitors must provide their own collar, leash, water dish, kennel and any equipment needed.
  - a. Obedience collars include well-fitting plain buckle or quick release collars, or slip collars of an appropriate single length of leather, fabric or chain with two rings, one on each end. Fancy collars, harnesses, head halters, studded collars, pinch collars with prongs or spikes on inside or outside, electronic collars, or any other special training collars, or collars that are either too tight or so large that they hang down unreasonably in front of the dogs are not permitted. Nothing shall be hanging from the collars. Leashes may be of fabric or leather and must be 6 feet in length for sub-novice classes. For novice and graduate novice classes, the leash need be only of sufficient length to provide adequate slack in the heel on leash exercise. Chain leashes are not acceptable.
  - b. Showmanship collars include a chain or fabric slip collar, or martingale-type show lead. Nothing shall be hanging from the collars. Leashes may be of fabric or leather and long enough to allow for easy handling of the dog. Chain leashes are not acceptable.
  - c. Head halters and harness are permitted in Assistance Dog and You and Your Dog classes only. They are not permitted in any of the Dog Obedience or Showmanship classes. Dumbbells must be made of one or more solid pieces of one of the heavy hard woods, or of a rigid or semi-rigid, firm, nontoxic, non-wooden material, similar in



size, shape, and weight to a wooden dumbbell. Metal dumbbells are not permitted. Dumbbells shall not be hollowed out. They shall have no decorations or attachments, but may bear an inconspicuous mark for identification. The size of the dumb bell shall be proportionate to the size of the dog.

19. Appearance

- a. Handler’s appearance: Exhibitor must be neat, clean and well-groomed in appearance. Exhibitor should be wearing clothing that is comfortable to handle in and appropriate for dog shows. Clothing should not distract, limit or hinder the judge’s view of the dog. (1) Acceptable clothing for all obedience, You and Your Dog and Assistants Dog classes includes slacks or colored jeans, collared blouses, or shirts. Blouses and shirts must be closed within one button from the top and tucked in all the way around the waist. Closed-toed shoes must be worn. (2) Acceptable clothing for girls in Showmanship classes are dresses, skirts, dress slacks, collared blouses, or similar attire. Closed-toed shoes must be worn. (3) Acceptable clothing for boys in Showmanship classes includes: Dress shirts, ties, and dress slacks. Sports jackets may be worn but are not necessary. Inappropriate Clothing for all classes includes clothing with holes or tears in the fabric, blue jeans, faded or torn jeans of any kind, leggings, sleeveless blouses, shirts, T-shirts or similar attire. Do not wear shirt with club names or logos, clothing with lettering or distracting/offensive wording or designs. Do not wear sandals, open toed shoes, clogs or similar type of footwear.
- b. Dog’s appearance: Dogs should be clean, well brushed and in good physical condition appropriate for the dog’s age. Regulation show slip is not required for the purebred dogs.

20. Exhibitors showing their dogs at any Licensed or Member Obedience Trial or at a Sanctioned Match must show their dogs at the same or higher B level classes than they are showing in AKC, UKC, or other titling shows. Dogs who have completed their Companion Dog (CD) title (or UKC, or other titling equivalents) prior to or anytime during the current project year must show in Graduate Novice classes at the very minimum. Dogs completing their Companion Dog Excellent (CDX) title (or UKC, or other titling equivalents) prior to or anytime during the current project year must show in Open or Graduate Open classes. Any dog receiving one or more legs towards a title anytime during the project year must then move into the appropriate B class at the time the first leg was earned. Showmanship classes, dogs with AKC Jr. Handling or like experiences must be shown in exhibitor age-appropriate B classes. Dogs completing a title prior to, or anytime during, the project year must show in exhibitor age-appropriate B classes. Any dog receiving points towards a championship title any time during the project year must then move into the appropriate B class at the time the points were first earned

21. Obedience Class and Eligibility

- a. Youth may show Beginner Novice A, Novice A, Graduate Novice A, Open A or Graduate Open A for one (1) year and then they must move to Beginner Novice B, Pre-Novice, Novice B, Graduate Novice B, Open B, or Graduate Open B. The “A” classes can never be repeated by handler OR dog. Youth may show in Beginner Novice B or Pre-Novice decided upon according to skill level and preference. Youth may show one or more project dogs in Beginner Novice B and Pre-Novice in the same year. A dog may not be shown in both Beginner Novice B and Pre-Novice in the same year. Youth may move back and forth between Beginner Novice B and Pre-Novice, from year to year, for no more than 3 years or 2 Hartford Fair scores of 200 points or more. Youth may show Novice B, Graduate Novice B, Open B, Or Graduate Open B for no more than 3 years or 2 Hartford Fair scores of 200 points or more.

22. Youth may show Rally Novice A, Rally Intermediate A, Rally Advanced A, and Rally Excellent A for one (1) year and then they must move to Rally Novice B, Rally Intermediate B, Rally Advanced B, and Rally Excellent B for no more than three (3) years or two (2) scores of 118 points or more. Youth may show one or more dogs in Rally.

23. Assistant

- a. Youth taking assistance dog projects may show their Assistance Dogs in You and Your Dog Classes. Youth must show in the appropriate age You and Your Dog level.
- b. Youth taking Assistance Dogs may show their Assistance Dogs one Beginning Obedience level/class (Beginner Novice A, Beginner Novice B, or Pre-Novice) that meets the exhibitor’s experience eligibility.

24. You & Your Dog

- a. Youth must be enrolled in You and Your Dog, Project No. 201D, to show in You and Your Dog Classes at the Hartford Fair. Youth must present their completed Dog Project and Record Book 201 and their dog for judging. The questions asked during the interview will come from the Ohio 4-H Dog Resource Handbook 201R.



All dogs must have an entry in Class JA for premium.

## **ALL JUNIOR FAIR MARKET ANIMAL EXHIBITORS**

### **GENERAL RULES**

1. Exhibits eligible to sell as outlined below:
 

A. Steer Pool	F. Gallon Milk
B. Market Beef Steer/Heifer	G. Commercial Meat Rabbit
C. Dairy Feeder Steer	H. Commercial Meat Poultry
D. Market Hog	I. Market Goat
E. Market Lamb	
2. Exhibitors are limited to sell a maximum of two (2) exhibits and only one exhibit per division. Note: Exhibits in rule 1A, B & C are considered one division. Market Steers and Dairy Feeder Steers are eligible for sale only if exhibitor is not selling a steer pool steer.
3. Meat projects and Gallon of Milk will be the only projects allowed to be sold at the sales sponsored by the Hartford Fair Board. The only additional item will be the traveling item sponsored by the Hartford Fair Board for the Youth Program.
4. Two percent (2%) will be deducted from sale price of all exhibits sold for sale promotion.
5. All harvested animals are subject to inspection by the Ohio Department of Agriculture. Discrepancies will be turned over to the Ohio Department of Agriculture. Payment is subject to Ohio Department of Agriculture inspection.
6. All Grand and Reserve Champions (as defined in rule #1 above) must sell, which counts towards your limit of two sales. One species per division per exhibitor may sell, except Grand and Reserve Champion which must sell.
7. The Hartford Independent Agricultural Society reserves the final and absolute right to interpret these rules and regulations and to arbitrarily settle and determine all matters, questions or differences in regard thereto, or otherwise arising out of, connected with, or incident to the Hartford Independent Fair. It further reserves the right to determine unforeseen matters not covered by these rules, to amend or add to these rules as in its judgment it may determine, and to withdraw all premium offering in all departments should any emergency exist and circumstances demand it.
8. Disregard of any rule by exhibitor, contestant, or concessionaires forfeits all premiums, rights and privileges without recourse and will subject the violator to such penalty as the Hartford Independent Fair Management may order.
9. In the event of conflict between the general rules and the special rules governing the various departments, the special rules will take precedence.
10. Unhealthy or unsound animals will not be eligible for sale.
11. All buyers will be provided a color photo on an “I Supported the Hartford Fair Sale” sign. Grand & Reserve Champions must have pictures taken with buyer unless the buyer wishes to remain anonymous.
12. All sale orders will be determined by a computer-generated random sort. Only Grand Champions and Reserve Champions will be moved to the top of the sale order. The only exception to this rule will be for Steer Pool exhibitors.
13. Sale checks will be mailed 30 days after the fair. The Hartford Fair reserves the right to withhold an exhibitor’s sale check if the situation is deemed necessary.

### **- Important Notice -**

Exhibitors are limited to sell a maximum of two (2) exhibits. One species per division per exhibitor may sell, except Grand and Reserve Champion which must sell. If you chose to participate in the Gallon of Milk Sale, this will count as one of the two.

All sale order will be determined by computer generated random sort. Only Grand and Reserve Champions will be moved to the top of the sale order. The only exception to this rule will be for Steer Pool – exhibitors will sell by draw number.

All weights, by the Hartford Fair’s (county certified) scales, will be final and no other scales will be allowed on the fair premises.

The livestock sale will be a “Premium” sale. Details available from Sr. & Jr. Fair Board Members.

**Sale checks will be mailed 30 days after the fair.  
There is a \$35 fee to re-issue checks not cashed  
within 60 days.**

**GALLON OF MILK**

1. The total dollar amount collected will be divided evenly among dairy exhibitors that chose to participate in sale.
2. Sale to be limited to 1/2 hour.
3. One representative gallon of milk will be sold.

**MARKET BEEF STEERS/HEIFER**

1. The champion and reserve champion must sell.
2. All must weigh at least 950# to sell.
3. At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand and Reserve Champions will be moved to top of sale
4. Buyers to absorb harvesting cost on top two animals.
5. Beef check-off will be deducted.

**DAIRY FEEDER STEERS**

1. Grand and Reserve Champion must sell.
2. At time of weigh in exhibitor must state which animal will be in the sale and a computer will randomly draw for sale order.
3. Only Grand and Reserve Champions will be moved to top of sale order.
4. Must weigh minimum of 400# in order to sell.
5. Beef check-off will be deducted.

\*\*\*\*\*

**STEER POOL**

1. All steer pool steers MUST sell.
2. The sale order is the same as drawing order.
3. Hauling cost will be deducted from all steer pool sales.
4. Harvest cost to be absorbed by the buyer of all steer pool animals.
5. All steer pool steers will go to carcass show.
6. Beef check-off will be deducted.

**MARKET HOG**

1. At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand Champion Gilt, Grand Champion Barrow, Reserve Champion Gilt, Reserve Champion Barrow will be moved to top of sale order.
2. Sale weights will be 200# & over. Under 200# will NOT sell in the Livestock Sale. There will be no re-weighs of hogs under 200#.
3. Pork check-off will be deducted.
4. \$1.00 tagging fee will be deducted.
5. Supreme Grand & Reserve must go to a fair approved processor. If you choose to participate in the Jr Livestock Sale, the hog designated to sell must be forfeited to the packer truck. Any hog not designated to sell is eligible to show in the Open Breeding/Market Show and must be off fairgrounds one hour after conclusion of show.

**MARKET LAMB & LAMB POOL**

1. The Overall Champion and Reserve Champion Single must sell. They will be harvested & tested.
2. At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Market Lambs - Only Grand and Reserve Champions will be moved to top of sale order. All lambs must weight minimum of 95# except Southdown and Cheviots, which must weigh 85#. All pen of two (2) lambs must weigh 190# except Southdown and Cheviots, which must weigh 170#.
3. Lamb and Wool check-off will be deducted.
4. All male lambs must be castrated.
5. The buyer will absorb harvesting cost.
6. All animals are to be slickshorn.

**MARKET GOATS**

1. Only one Market Goat per exhibitor, regardless of 4-H or FFA, may be sold, except if an exhibitor has Grand and/or Reserve Champion in more than one area of this sale.
2. At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand Champion and Reserve Champion will be moved to top of sale order.
3. Grand and Reserve Champion Market Goats MUST sell.
4. Exhibitor must be present with project at show and sale. Exceptions can be made at the discretion of Sale Committee.
5. Grand and Reserve Champions must have pictures taken with buyer unless the buyer wishes to remain anonymous.
6. A minimum weight of 45# for a Market Goat will be required to sell the Market Goat. A member of the Small Animals Sale Committee will be present at Market Goat weigh-ins.
7. All animals are to be slickshorn
8. Market Goats sold by lot, not by pound
9. The buyer will absorb harvesting hauling cost.

\*\*\*\*\*

**POULTRY**

1. Only one lot per exhibitor may be sold, except if an exhibitor has Grand and/or Reserve Champion in more than one area of this sale.
2. All Grand and Reserve Champions of meats must sell.
3. At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand and Reserve Champions will be moved to top of sale order.
4. Exhibitors must be present with project at sale. Exceptions can be made at the discretion of Sale Committee.
5. Meat classes: Chicken, Duck, Geese, & Turkey projects may sell at sale. (Market poultry raised for meat purposes only, commercial)
6. Egg laying & Fancy classes will not sell.
7. Grand and Reserve Champions must have pictures taken with buyer unless the buyer wishes to remain anonymous.
8. Animals sold by lot and not by the pound.

**RABBITS**

1. Only one lot of meat project may be sold per exhibitor except if a member has Grand and/or Reserve Champion in more than one area of this sale.
2. All Grand and Reserve Champion meat projects must sell.
3. At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand and Reserve Champions will be moved to top of sale order.
4. Exhibitors must be present with project at sale. Exceptions can be made at the discretion of Sale Committee.
5. Animals are sold by the lot, not by the pound.
6. Grand and Reserve Champion must have pictures taken with buyer unless the buyer wishes to remain anonymous.
