# BREEDING SHEEP USDA Identification Program

All intact breeding animals entered in the Hartford Fair for the purpose of participating in the sheep breeding class shows must follow guidelines as listed below

- All intact breeding animals must be identified with official USDA approved identification. (USDA approved tags, USDA approved tattoos, or identification in the scrapie Flock Certification)
  - All registered animals with accompanying registration tattoos would be acceptable once flock is registered with USDA (registration tags are not acceptable);
  - b. If the breeding animal was purchased outside of Ohio, the animal must have official USDA identification as well as a Certificate of Veterinary Inspection (CVI) signed by both the veterinarian and the exhibitor within 30 days of the opening of the Hartford Fair. (CVI must attest to the following: "the sheep in this shipment are not known to be under any movement restrictions because of scrapie.")

- 1. There will be a limit of 3 singles and 1 pen of two for a maximum total of 5 animals.
- 2. ALL MARKET LAMBS WILL BE IDENTIFIED BY EAR TAGS ONLY. LAMBS NOT TAGGED ON THE FIRST SATURDAY IN May 2021 WILLNOT be eligible to show
- 3. All Market Lambs MUST be slick shorn above the hock & knee & wool cap is permissible at least one week or less prior to fair.
- The only animals that will be harvested will be the Overall Champion and Res. Champion Single.
- 5. All Market Lambs must stay in designated areas on show day. Designated areas are:
  - Sheep wash rack
  - Market Lamb Barn or Goat Barn
  - Grooming stand area located South of the Market Lamb Barn.
  - Make up area in Grubb Arena (after the Market Lamb
  - Visible site
- Market Lambs must enter show ring dry. Wet lambs will not be eligible to place.
- 7. Absolutely NO Rams allowed to show
- **8.** Bedding must be straw or pine shavings only.
- 9. Unacceptable Practices:
  - Applying any electrical, mechanical, or other appliance to livestock repeatedly or for a prolonged time period is in violation of section 313.2 of the U.S. code of federal regulations.
  - Using ice, ice packs, cold packs or cold compresses internally or externally other than in accordance with paragraph (S) of rule 901-19-12 of the Administrative Code. (This includes wet towels or wet blankets, etc.).
  - Using a stomach tube or pump for any purpose other than for the relief of tympany or gas on the day of exhibiting. Using any substance to enhance or change the color of the livestock, including the livestock's hide or hooves. Adding any substance externally to build up, change or alter the shape or conformation of the livestock, including by way of example but not limited to rope, false hair, graphite, hemp, and powders. This includes powders, powdered paints, and paint, per state veterinarian.
- 11. Underweight Lambs (as defined in the Jr. Fair rules published in the beginning of the Jr. Fair section of this tabloid) will be exhibited for a grade only and are not eligible rosettes, champion and reserve champion drive, or for the market lamb sale. Underweights lambs ARE eligible for showmanship.
- 12. Any exhibitor performing an unacceptable practice, the animal will be disqualified from the show and sale.

13.	Center dividers must remain in and fastened to back of the pen if taken down. Cannot remove 2 consecutive center dividers. Hartford Fair Board reserves the right to put dividers back
14.	No tack allowed in pens. The Hartford Fair board reserves the right to remove any tack from pens not being used to stall animals
15.	All trailers left on fairgrounds during fair week must be parked in designated area.
16.	Any sheep that show evidence of Fungus, Sore mouth, Foot Rot, or Prolapse, must be removed from the fairgrounds immediately.

- 1. Sign-up Deadline: Registration forms must be returned to address on the application by the first Saturday in April of current year. Applications are available through the Licking Co. Extension Office and Hartford Fair websites.
- Selection will be the last Sunday in April at 3:00 pm (Location TBA)
- Price to be determined. A \$25 deposit must accompany completed registration form and balance is due the last Saturday of April prior to lamb selection process getting underway
- 4. All lambs purchased through the Lamb Pool will be of sound condition as possible by the producer. If lamb expires within 20 days of selection and no fault of exhibitor, the lamb will be replaced by the Lambs will be tagged for the Hartford Fair on selection day.
- There will be a selection/entry limit of two Lamb Pool lambs per exhibitor. Both lambs will be entered and exhibited as singles, no Pen of 2 classes will beoffered.
- 7. Lambs will be obtained from producers within the Hartford Fair district. If a sufficient number of lambs cannot be found within the fair district, then flocks from outside the fair district will be considered.
- The lambs will be of consistent size and quality and will be blackfaced lambs of Suffolk and/or Hampshire breeding.
- 9. Lambs will follow all rules and regulations pertaining to the Hartford Fair Market Lamb show, as written in the Hartford Fair Book.
- 10. There will be no additional club enrollment required; members of the Lamb Pool will be required to maintain membership in their respective 4-H Club or FFA Chapter and carry a Market Lamb project.
- 11. Lambs will be housed in the Sheep Barn during the Hartford Fair.
- 12. The top two lambs in each class will receive awards. Those top two lambs will then return to show for a top five overall awards to be held after the other market lamb classes have concluded.
- 13. The top two from the Lamb Pool show will then complete against the top 2 lambs from the Market Lamb show during the selection of the overall Grand Champion and designation of the top ten lambs.
- 14. Lamb Pool exhibitors are eligible to show their lambs in the Market Lamb Showmanship classes. There will not be a separate showmanship class for Lamb Poolexhibitors.

Ewe lambs entered in the market lamb show, as well as all wethers, that were purchased outside of Ohio must have USDA approved identification and required to have a Certificate of Veterinary Inspection (CVI) signed by both the veterinarian and the exhibitor within 30 days of the opening of the Hartford Fair. (CVI) must attest to the following: "the sheep in this shipment are not known to be under any movement restrictions because of scrapie.")

- Exhibitors are limited to sell a maximum of two (2) exhibits and only one exhibit per division. Note: Exhibits in rule 1A, B & C are considered one division. Market Steers and Dairy Feeder Steers are eligible for sale only if exhibitor is not selling a steer pool steer.
- 3. Meat projects and Gallon of Milk will be the only projects allowed to be sold at the sales sponsored by the Hartford Fair Board. The only additional item will be the traveling item sponsored by the Hartford Fair Board for the Youth Program.
- Two percent (2%) will be deducted from sale price of all exhibits sold for sale promotion.
- All harvested animals are subject to inspection by the Ohio Department of Agriculture. Discrepancies will be turned over to the Ohio Department of Agriculture. Payment is subject to Ohio Department of Agriculture inspection.
- All Grand and Reserve Champions (as defined in rule #1 above) must sell, which counts towards your limit of two sales. One species per division per exhibitor may sell, except Grand and Reserve Champion which must sell.
- The Hartford Independent Agricultural Society reserves the final and absolute right to interpret these rules and regulations and to arbitrarily settle and determine all matters, questions or differences in regard thereto, or otherwise arising out of, connected with, or incident to the Hartford Independent Fair. It further reserves the right to determine unforeseen matters not covered by these rules, to amend or add to these rules as in its judgment it may determine, and to withdraw all premium offering in all departments should any emergency exist and circumstances demand
- Disregard of any rule by exhibitor, contestant, or concessionaires forfeits all premiums, rights and privileges without recourse and will subject the violator to such penalty as the Hartford Independent Fair Management may order.
- In the event of conflict between the general rules and the special rules governing the various departments, the special rules will take
- 10. Unhealthy or unsound animals will not be eligible for sale.
- 11. All buyers will be provided a color photo on an "I Supported the Hartford Fair Sale" sign. Grand & Reserve Champions must have pictures taken with buyer unless the buyer wishes to remain anonymous.
- 12. All sale orders will be determined by a computer-generated random sort. Only Grand Champions and Reserve Champions will be moved to the top of the sale order. The only exception to this rule will be for Steer Pool exhibitors.
- Sale checks will be mailed 30 days after the fair. The Hartford Fair reserves the right to withhold an exhibitor's sale check if the situation is deemed necessary.

Exhibitors are limited to sell a maximum of two (2) exhibits. One species per division per exhibitor may sell, except Grand and Reserve Champion which must sell. If you chose to participate in the Gallon of Milk Sale, this will count as one of the two.

All sale order will be determined by computer generated random sort. Only Grand and Reserve Champions will be moved to the top of the sale order. The only exception to this rule will be for Steer Pool - exhibitors will sell by draw number.

All weights, by the Hartford Fair's (county certified) scales, will be final and no other scales will be allowed on the fair premises.

The livestock sale will be a "Premium" sale. Details available from Sr. & Jr. Fair Board Members.

Sale checks will be mailed 30 days after the fair. There is a \$35 fee to re-issue checks not cashed within 60 days.

# **GALLON OF MILK**

- The total dollar amount collected will be divided evenly among dairy exhibitors that chose to participate in sale.
- 2. Sale to be limited to 1/2hour.
- 3. One representative gallon of milk will be sold.

#### MARKET BEEF STEERS/HEIFER

- 1. The champion and reserve champion must sell.
- 2. All must weigh at least 950# to sell.
- At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand and Reserve Champions will be moved to top of sale
- 4. Buyers to absorb harvesting cost on top two animals.
- 5. Beef check-off will be deducted.

# **DAIRY FEEDER STEERS**

- 1. Grand and Reserve Champion must sell.
- 2. At time of weigh in exhibitor must state which animal will be in the sale and a computer will randomly draw for sale order.
- Only Grand and Reserve Champions will be moved to top of sale order.
- 4. Must weigh minimum of 400# in order to sell.
- 5. Beef check-off will be deducted.

#### **STEER POOL**

- 1. All steer pool steers MUST sell.
- 2. The sale order is the same as drawing order.
- 3. Hauling cost will be deducted from all steer pool sales.
- 4. Harvest cost to be absorbed by the buyer of all steer pool animals.
- 5. All steer pool steers will go to carcass show.
- 6. Beef check-off will be deducted.

## **MARKET HOG**

- At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand Champion Gilt, Grand Champion Barrow, Reserve Champion Gilt, Reserve Champion Barrow will be moved to top of sale order.
- Sale weights will be 200# & over. Under 200# will NOT sell in the Livestock Sale. There will be no re-weighs of hogs under 200#.
- 3. Pork check-off will be deducted.
- 4. \$1.00 tagging fee will be deducted.
- 5. Supreme Grand & Reserve must go to a fair approved processor. If you choose to participate in the Jr Livestock Sale, the hog designated to sell must be forfeited to the packer truck. Any hog not designated to sell is eligible to show in the Open Breeding/Market Show and must be off fairgrounds one hour after conclusion of show.

MARKET LAMB & LAMB POOL

- The Overall Champion and Reserve Champion Single must sell. They will be harvested & tested.
- 2. At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Market Lambs Only Grand and Reserve Champions will be moved to top of sale order. All lambs must weight minimum of 95# except Southdown and Cheviots, which must weigh 85#. All pen of two (2) lambs must weigh 190# except Southdown and Cheviots, which must weigh 170#.
- 3. Lamb and Wool check-off will be deducted.
- 4. All male lambs must be castrated.
- 5. The buyer will absorb harvesting cost.
- 6. All animals are to be slick shorn.

### **MARKET GOATS**

- Only one Market Goat per exhibitor, regardless of 4-H or FFA, may be sold, except if an exhibitor has Grand and/or Reserve Champion in more than one area of this sale.
- At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand Champion and Reserve Champion will be moved to top of sale order.
- 3. Grand and Reserve Champion Market Goats MUST sell.
- Exhibitor must be present with project at show and sale.
   Exceptions can be made at the discretion of Sale Committee.
- Grand and Reserve Champions must have pictures taken with buyer unless the buyer wishes to remain anonymous.
- A minimum weight of 45# for a Market Goat will be required to sell the Market Goat. A member of the Small Animals Sale Committee will be present at Market Goat weigh-ins.
- 7. All animals are to be slick shorn
- 8. Market Goats sold by lot, not by pound
- 9. The buyer will absorb harvesting hauling cost.

### **POULTRY**

- Only one lot per exhibitor may be sold, except if an exhibitor has Grand and/or Reserve Champion in more than one area of this sale.
- 2. All Grand and Reserve Champions of meats must sell.
- At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand and Reserve Champions will be moved to top of sale order.
- 4. Exhibitors must be present with project at sale. Exceptions can be made at the discretion of Sale Committee.
- 5. Meat classes: Chicken, Duck, Geese, & Turkey projects may sell at sale. (Market poultry raised for meat purposes only, commercial)
- 6. Egg laying & Fancy classes will not sell.
- 7. Grand and Reserve Champions must have pictures taken with buyer unless the buyer wishes to remain anonymous.
- 8. Animals sold by lot and not by the pound.

## RABBITS

- Only one lot of meat project may be sold per exhibitor except if a member has Grand and/or Reserve Champion in more than one area of this sale
- 2. All Grand and Reserve Champion meat projects must sell.
- At time of weigh in exhibitor must state which animal will be in sale and computer will draw randomly for sale order. Only Grand and Reserve Champions will be moved to top of sale order.
- Exhibitors must be present with project at sale. Exceptions can be made at the discretion of Sale Committee.
- 5. Animals are sold by the lot, not by the pound.
- 6. Grand and Reserve Champion must have pictures taken with buyer unless the buyer wishes to remain anonymous.
