



## Hartford Fair Camping Rules & Regulations

- I. Permit Acquisition:
- PERMIT REGISTRATION MUST BE COMPLETED BEFORE ENTERING THE CAMPGROUNDS. REGISTRATIONS WILL BE EMAILED TO LOT HOLDERS FOLLOWING THE LOTTERY. CAMPING PERMITS WILL BE DISTRIBUTED DIGITALLY PRIOR TO OFFICIAL MOVE IN DAY. A \$25.00 FEE WILL BE CHARGED TO HAVE THE VEHICLE AND/OR RV OR CAMPSITE PERMIT UPDATED OR CHANGED FOLLOWING THE YEARLY REGISTRTRION. **PLEASE MAKE SURE THE REGISTRATION IS FILLED OUT COMPLETELY AND ACCURATELY, PERMITS WILL BE TRACKED BY INFORMATION YOU PROVIDE DURING THE REGISTRATION PROCESS.**
  - Only **ONE** vehicle other than the RV vehicle is permitted to registered and/or park on the lot and this vehicle must display the parking permit. Additional vehicles must be parked in the general parking lots. This rule will be strictly enforced. THERE WILL BE PREFERRED PARKING PERMITS AVAILABLE FOR \$20.00. THIS PARKING AREA IS LOCATED DIRECTLY BEHIND THE HOG BARN.
  - It is the permit-holder's responsibility to inform the Hartford Fair of any change in addresses, phone numbers, or email.
  - You must be 21 years of age to register an RV or tent campsite and you will be responsible for all occupants and guests.
- II. Arrival/Departure to and from Campground:
- Campers will not be permitted entry before 12:00 PM NOON, Tuesday before the Hartford Fair (North Lot Only, in preparation for move in day on Wednesday). Official day to move onto the Lot is the Wednesday before the Fair at 8:00 AM. When entering the campground you MUST show the Digital Ticket provided by HOMETOWN TICKETING so your RV can be scanned into campground.
  - All Campers must access the campground through the designated gate. Beginning Saturday before Fair the only gate accessible to the campgrounds will be A4. All other gates will not be accessible to the campgrounds. All others must park in the general parking lots.
  - All occupants must exit the grounds by 8:00 AM on Monday following the final day of Fair.
- III. Campground Rules and Regulations:
- All camping units must have a license plate and it must be accurately registered with the Hartford Fair. If you are tent camping contact the office for a temporary license ID). If you are issued a temporary license ID it must be visibly displayed nearest to the door of the tent.
  - No electric cords are to run across roadway and only ONE electric outlet is allowed per camping lot.
  - No alcoholic beverages are permitted on the fairgrounds.
  - 11:00 PM to 7:00AM will be quiet time and all fires and outside lights must be out or off by 12:00 AM midnight.
  - NO GENERATORS ARE PERMITTED TO RUN BETWEEN THE HOURS OF 11:00 PM AND 7:00 AM.
  - There shall be no pets in the campgrounds.
  - All trash must be placed in dumpsters before 8:00 AM.
  - Dumping gray water and sewage on the ground is forbidden. There is a gray water dumping station located in the campgrounds for your convenience. A service will be available daily during the fair to pump RV's and the times and fee will be posted at the shelter house. Anyone found abusing this rule will forfeit their camping privileges.
  - Camper is responsible for keeping campground site and all fixtures in a clear and safe condition. Camper must remove all fire rings, garbage, rubbish, and other waste in a clear and safe manner, to the place provided by the Hartford Fairgrounds. Camper will use all electrical, plumbing, and other facilities and appliances in a reasonable manner. Camper will not destroy or damage any part of the campgrounds
  - Absolutely no pruning or cutting of any trees, limbs, or shrubs without permission of the Senior Fair Board. Doing so will void this agreement with the Hartford Fair and Camper will be required to leave the campsite for the remainder of the Hartford Fair.**
  - Golf carts, bikes, ATV's, recreational or similar motorized vehicles are prohibited. No Exceptions. Power chairs for the physically challenged will be available for rent at the gates.
  - The Hartford Fair reserves the right to ask Camper to remove any personal property brought onto lot, including but not limited to any refrigerator and or freezer plugged in outside Camper's RV if it is causing electrical issues.
  - No sub-leasing or switching of lots is permitted. Only one RV or tent will be permitted on each lot. Only one campsite is permitted per household, name, and/or address.
  - If Camper is found to be in violation of any of the aforementioned Rules and Regulations, the Senior Fair Board, or any other person authorized by the Hartford Fair, may issue a warning. If the violation is not corrected, a fine of \$25.00 for each violation may be issued per day. In the alternative, the Senior Fair Board, or any other person authorized by the Hartford Fair may expel Camper from the Lot he or she has reserved for the remainder of the Hartford Fair and the Camper shall not be entitled to refunds. THIS WILL BE STRICTLY ENFORCED!
- IV. Disclaimer/Release from Liability
- The Hartford Fair disclaims any representation, warranty, or guarantee as to the safety of all property brought to the premise by Camper. The Hartford Fair assumes no responsibility for damage to a trailer or camping vehicle for any reason including but not limited to vandalism, natural causes, or acts of God. Additionally, the Hartford Fair assumes no responsibility for proper or necessary maintenance of Camper's trailer or camping vehicle during the term of this agreement.**
  - Camper, his/her heirs, designees, assignees, agents, do forever release, acquit, and discharge the Hartford Independent Agricultural Society (DBA The Hartford Fair) and each of its respective subsidiaries, affiliates, divisions, officers, directors, employees, agents, successors, and assigns, both in their official and personal capacities, whichever may be applicable, from any and all claims, demands, judgments, actions, causes of actions, unknown, vested or contingent in law, equity, or otherwise arising under or from any claim asserted or that could have been asserted, or otherwise from the contract.**
- V. Payment:
- Only Cash or Credit/Debit Cards will be accepted after the May 1<sup>st</sup> deadline for registration. NO CHECKS. In case of an error in payment processing, any reserved lot will be lost if not paid by the Late Deadline Fee of June 1<sup>st</sup>. A Late Fee shall be added to the base camping fee and may only be paid with cash or with credit card.**
